Preamble:-

Vide GR dated 30.7.04, as stated at sr.no.2 in read, Department of Science and Technology has issued guidelines for annual maintenance contract (AMC) of LAN hardware and associated systems. Over the year several government offices up to Talukas level have been computerized .Generally these offices have a small set up of Computer Hardwares and associated systems. It is a known fact that hardly a few vendors exist at districts and talukas HQ who can fulfil the turnover requirement of the eligibility criteria as prescribed in the above mentioned GR dated.30/07/04. Thus, a large number of government offices at various District/Talukas locations are unable to appoint appropriate vendors for AMC of computer hardware & associated systems and, therefore, a few representations have been received to liberalize the turnover requirement mentioned in the eligibility criterion of the aforesaid GR. This matter of relaxation in the eligibility criteria was under active consideration of the Govt.

Resolution:-

The state Government is pleased to amend the above mentioned Government Resolution dated 30/7/04 as following ;

- 1.“A . Bidders' eligibility Criteria” of the said GR should be read as “A(i) Bidders' eligibility Criteria”
2. A new clause “A(ii)” is inserted below para “A . Bidders' eligibility Criteria”,as under;

“A(ii) Bidders' eligibility Criteria for smaller office set up”

“In case the total amount of Annual Maintenance Contract (AMC) including all kind of Computer Hardware and associated system does not exceeds of Rs. 1 lacs, the bidder should have a minimum of annual turnover of Rs. 10 lacs each for last 3 years.”
