INTRODUCTION:

Government of Gujarat has been continuously endeavoring to provide Good governance through e-Governance leveraging Information and Communication Technology (ICT). To implement eGovernance across the state, Government of Gujarat has setup a sturdy shared ICT infrastructure which comprises of Gujarat State Data Center (GSDC), Gujarat State Wide Area Network (GSWAN), City Civic Centers, ATVT (Apano Taluko Vibrant Taluko) Centers and eGram Centers. On one hand, this has helped Government to improve the quality, efficiency and transparency in delivery of public services by optimum use of shared ICT infrastructure while on the other hand it has facilitated the citizens to avail the services in secured manner conveniently in their locality.

2. Gujarat State Data Centre (GSDC) is one of the core components of the shared ICT infrastructure and includes 2600 sq. ft of server & storage area, 600 sq. ft of connectivity zone and 1300 sq. ft of control room & utility area. It is connected to most of the Government offices through Gujarat State Wide Area Network (GSWAN).

3. The GSDC has been equipped to host / co-locate systems such as Web Servers, Application Servers, Database Servers, SAN, and NAS etc. GSDC provides much functionality such as Central Repository of the State, Secure Data Storage, Citizen Information/Services Portal, State Intranet Portal, Disaster Recovery, Remote Management and Service Integration etc. GSDC also provides highly secured environment, better operation & management control and minimizes overall cost of Application Deployment, Data Management, IT Resource Management etc.

4. Recently, Government of Gujarat has awarded the work for overall upgradation of the Gujarat State Wide Area Network (GSWAN) in consonance with upgradation of the Gujarat State Data Centre (GSDC) including provision of composite O&M (GSWAN and GSDC) for administrative & coordination convenience. Simultaneously, the Government has also awarded the work for upgradation of connectivity through BSNL including additional PoPs with an objective to provide stable and scaled connectivity. The overall upgradation of shared infrastructure will certainly enhance overall user experience multi-fold.

OBJECTIVE:

The objective of these guidelines is to ensure optimum utilization of the shared ICT infrastructure by the Government Departments/PSUs/Corporations without creating duplication of Network and Data centre components (Other than servers). The applications / websites of Government of Gujarat & associated IT infrastructure shall be hosted at one secured place i.e. State Data Centre & utilize shared infrastructure of State Data Centre & State Wide Area Network.

CIRCULAR:

A. For Government departments / offices

1. All Government Departments implementing any IT / eGovernance Project shall ensure that any software application / web application / mobile application /

website as well as IT infrastructure shall be hosted at Gujarat State Data Centre (GSDC).

2. The Departments Must utilize common / shared infrastructure available at GSDC which includes but is not limited to controlled uninterrupted power supply, cooling systems, physical security & access control, networking & security infrastructure (such as UTM firewall, load balancer, Switches, Antivirus software), storage system along with a storage network, tape library & backup system, racks etc.
 3. Looking to the above mentioned common/shared infrastructure availability, Government Department should not consider the common software and hardware devices (other than servers) available at GSDC while preparing the bill of material (BoM) which should also be vetted by Department of Science & Technology before finalizing.
- B.** Consultants like GIL/GIPL/NIC/iNDEXTb, who are assisting / facilitating Government Departments in their IT / eGovernance projects shall take due care while designing the bill of material by considering the central IT infrastructure of GSDC & accordingly prepare the Request for Proposal (RFP) / Tender for the proposed requirement of Department.
- C.** All Government Departments & their consultants are hereby advised to consider the strict adherence to the above points pertaining to utilization of common / shared infrastructure available at State Data Centre (SDC) & State Wide Area Network (SWAN) while preparing Request for Proposal (RFP) / Tenders for implementation of their respective IT / eGovernance Projects.
